Congresswoman Christensen chaired the Congressional Black Caucus' Health Braintrust

for 16 years. She practiced family medicine and served in several public health administrative positions prior to her election to Congress in 1996. She recently established the Christensen Institute for Community Health and Empowerment. Dr. Christensen is the recipient of several honorary degrees and awards. Today she is a board member of Consumers4QualityCare, chairs the IGT Scientific, Academic and Medical Council, is on the Board of Virgin Islands Architectural Center, Frederiksted Health Care, Inc ( an FQHC), American Kidney Fund and several other boards. She currently serves on the Board of Advisors for C-PAC and is active in the organization's various community engagement activities.
